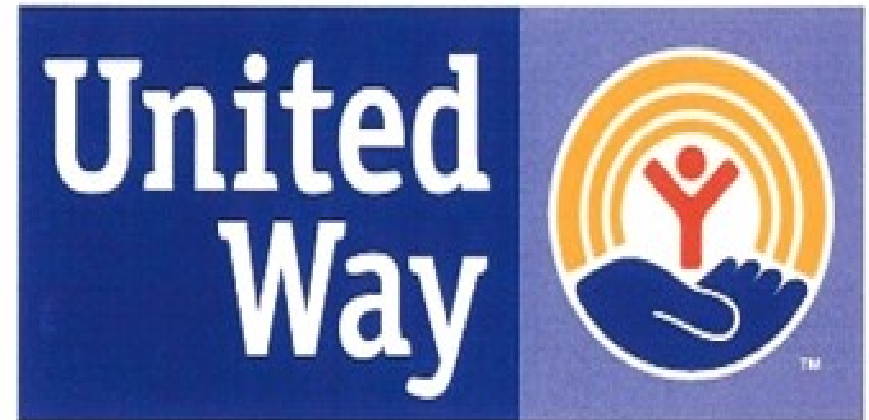

Knowing these facts, and in consideration of your accepting my entry, I hereby for myself, my heirs, executors, administrators or anyone else who might claim on my behalf covenant not to sue, and waive and release and discharge any and all race sponsors, race officials, volunteers, local and state police including any and all of their agents, employees, assigns or anyone acting for or on their behalf from any and all damages or liability for death, personal injury or property damage of any kind or nature whatsoever arising out of, or in the course of, my participating in this event, whether same be caused by negligence or fault. ### Directions

**From the North** - On the Muskogee Turnpike look for Exit 33 (or "Port of Muskogee") just after crossing the Arkansas River. Take this exit and turn left (East) at the stop sign, crossing over the Muskogee Turnpike. Look for the Batfish sign on left.

**From the South** - On the Muskogee Turnpike, look for Exit 33 (or "Port of Muskogee", "War Memorial Park"). Take this exit and turn right (East) at the stop sign and look for the BATFISH sign on the left.

When you see the Batfish sign, turn left (North). Follow this road for about ½ mile. You will pass over railroad tracks and through a gate. When the road dead-ends, turn left into the War Memorial Park parking lot.
